

1 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF
2 LAUDERDALE LAKES as follows:

3 SECTION 1. RECITALS. The foregoing recitals are true and correct and are incorporated
4 herein by this reference.

5 SECTION 2. AUTHORITY. This Ordinance is enacted pursuant to Chapter 1, Section 1-7
6 of the Code of Ordinances, City of Lauderdale Lakes, Florida and other applicable provisions of
7 law.

8 SECTION 3. AMENDMENT: That Chapter 82-Taxation and Finance, Article VI, Section
9 82-195 of the Code of Ordinances, City of Lauderdale Lakes, Florida is hereby amended to read
10 as follows:

11 Sec. 82-195. - Contributions to private organizations; limitations and requirements.
12 All contributions made by the city to private organizations shall be made only to affect a public purpose,
13 with substantial benefit to the city. As a prerequisite to the contribution of such funds, a requesting
14 organization shall file an application therefor, on such forms as shall be provided by the city clerk,
15 stating the organization's name and address, telephone number, facsimile number and e-mail address,
16 the names and addresses of the board of directors or the principal controlling officers, in the event the
17 organization is not incorporated, the amount of the requested contribution and a justification
18 statement reflecting that the funds are to be utilized to further a public purpose which will have
19 substantial and direct benefit to the city. Each such organization shall also file with the city, in addition
20 to such application, a sworn and notarized declaration attesting that (a) such person executing the
21 declaration on behalf of the organization has authority to do so, and (b) the organization has fully
22 complied with the registration and other requirements set forth in section 496.405, F.S., or if exempt from
23 registration, has complied with the requirements set forth in section 496.406, F.S. Such declaration shall
24 be on a form prepared by and available at the office of the City Clerk, and each sworn declaration shall
25 not be dated more than thirty (30) days prior to the date of the organization's application to the City. ~~Such~~
26 organization shall file with the city, in addition to such application, a certified financial statement which
27 shall not be dated more than one year prior to the request for contribution.

29 SECTION 4. INSTRUCTION TO THE CITY MANAGER AND CITY CLERK: The City Manager
30 is instructed to prepare the declaration form and make such available in the office of the City

2 SECTION 5. CONFLICTS: All ordinances or Code provisions in conflict herewith are
3 hereby repealed.

4 SECTION 6. SEVERABILITY: If any section, subsection, sentence, clause, phrase or
5 portion of this Ordinance is for any reason held invalid or unconstitutional by any court of
6 competent jurisdiction, such portion shall be deemed a separate, distinct and independent
7 provision and such holding shall not affect the validity of the remaining portions of this
8 Ordinance.

9 SECTION 7. INCLUSION IN THE CODE OF ORDINANCES: It is the intention of the City
10 Commission of the City of Lauderdale Lakes that the provisions of this Ordinance shall become
11 and be made a part of the Code of Ordinances in the City of Lauderdale Lakes and that the
12 sections of this Ordinance may be renumbered or relettered and the word "Ordinance" may be
13 changed to "Chapter," "Section," "Article" or such other appropriate word or phrase, the use of
14 which shall accomplish the intentions herein expressed; provided, however, that Section 1 hereof
15 or the provisions contemplated thereby shall not be codified.
