

# American Rescue Plan Act of 2021



## AMERICAN RESCUE PLAN ACT

President Biden signed the \$1.9 trillion American Rescue Plan Act of 2021 (ARPA) into law on 3/11/21



## PROCESS & ALLOCATION

- >Aid will be released to states in May after states submitting certification to Department of Treasury
- >States will receive disbursements for non-entitlement unit of local government.
- States must disburse funds to non-entitlements within 30 days of receiving funding, or request an extension with justification for request
- > States are not permitted to change funding allocations or add additional requirements to nonentitlement units of local government
- CDBG City: Cities with population of 50k+
- Non-entitlement: Cities with population below 50k
- > State of Florida allocation: 10.31 billion
- **► Lauderdale Lakes allocation: \$15,209,523**

Open Gov - Transparency Portal	Technology	With the increase for transparency in financial reporting and budgeting as it relates to the additional funding, this tool will assist staff in providing full disclosure and efficiency. Many of the operations are manual processes, such as financial reporting, budget reports and all of the budget forms to include CIP applications. This system has the ability to automate all of the processes for faster analysis and standardized reporting. In addition, the system can provides a transparency portal, whereby residents and constiuents are able to see the actuals online.	50,000
ARP Purchasing and Contracts Officer (Contract Position)	Contractual Position	Due to the increase in the demand to procure equipment, supplies and to manage contracts to support the American Rescue Plan Projects, it is recommended that a Contractor is hired for a period of time to assist with the solicitation to the project close out activities.	112,320
Free WiFi at Citywide Parks	Technology	The City conducted a marketing research study in August 2017. The study framed the issue of expanding social media marketing to maximize access for citizens. Offering free and fast WiFi access helps customers to stay connected and productive while they are at the park. During FY2021, free Wifi was launched at Vincent Memorial Park, which is the most widely used park. Moving ahead, is it in the best interest to expand to other parks: Willie Web Senior Park, Otis Gray, Educational and Cultural Center/North Gate Neighborhood Park.  This enhanced level of service increases visitation and ultimately gets people to attend and participate in events at the park as well as spend time outside. Benefits of public internet access: tool to monitor visitation patterns, ability to target messaging to park visitors, access to the underserved the communities, and potential to generate revenue through public, private, partnerships.  This will be an ongoing cost to maintain.	20,000
Replacement of the Citywide Telephone System	Technology	The City currently is using the Samsung Telephony System, which is xx years old. In the last few years it has been become increasingly difficult to find repair parts due to the model of the system. It is recommended that the system be upgraded to improve communication and productivity in the organization. An upgraded telephony system should be able to integrate telephone, video conferencing, teleconferencing, instant messaging, texting and social media. Upgrading or improving the telephone system will improve the efficiency of the workplace. It is recommended that telephone systems be upgraded every five years.	70,000

An outcome of the study was to implement an online self-service portal for customers to make payments online. Online payments are faster and will save customers time with less effort. Electronic payments will reduce costs involved in physical transactions, such as driving, waiting in line, printing invoices and receipts, etc. Electronic payments are standardized, offer payment security, have lower labor costs, can reach larger audiences and offer conveniences. Electronic transactions also provides error free payments and low risk of theft. In addition, the City can invest in an application development for mobile devices.	100,000
CyberSecurity Assessment	Technology	The need to increase cybersecurity awareness and threat detection can be assisted/achieved by consulting a cyber security professional to do a SWOT Analysis on our network. Findings will determine what direction we take next. In regards to acquiring necessary software/hardware to increase our cyber security protection against hackers, malware, ransomware etc.	50,000
ARP Accountant IV and II (Contract Position)	Contractual Position	On a yearly average, the Accounting Division processes 2,976 Journal Entries, issues 2,328 checks, sends 1,188 wire transfers to vendors, processes 696 Electronic Fund Transfers and 6,512 Invoices and spending upward of \$30 million. Adding an additional \$7.5million to our budget annually under the American Recovery Plan will dramatically add accounting transactions to workload of existing team members. It is not expected that the existing team members cannot handle the current workload and the anticipated workload driven by an additional \$7.5 million in spending anticipated annually. We will be required to add a ARP Accountant 4 (\$50/hour) and an Accountant II (\$25/hour) in order to support the anticipated workload. These positions will be contractual and funded from the proceeds derived from the ARP (American Recovery Plan). The expected time period for these two positions will be from May 3, 2021 to April 28, 2023. These positions will be responsible for all accounting transactions and reporting related to the ARP.	312,000
	Loss of FY 2020 Revenues	In FY 2020 we were impacted dramatically on our ability to collect various sources included in our general fund and gas tax fund. The impacted revenues include Communications Service Tax, Electric Franchise Fee, Electric Utility Fee, 1/2 Cent Sales Tax, State Share, Recreation Fees, Occupational Liscense Fee, Certificate of Use and Gas Tax Revenues.	801,747
