15	October 1, 2021 ("Fiscal Year 2022"), and further scheduled the two public hearings required by	
16	Section 200.065(2)(b), Florida Statutes, the first to be held on September 15, 2021, at 5:01 p.m., ar	
17	the second hearing to be held on September 23, 2021;	
18	WHEREAS, the City Manager has recommended an annual budget for Fiscal Year 2022	
19	commencing October 1, 2021. The City Manager also recommended to adopt a separate City of	
20	Lauderdale Lakes Fiscal Year 2022 tentative voted debt service millage of 1.0950 mils for	
21	combined total tentative millage rate of 9.6950; and	
22	WHEREAS, the public and all interested residents, persons or parties will have the	
23	opportunity to address their comments to the City Commission, and the City Commission wi	
24	first consider the comments of the public regarding the tentative millage rate.

1 ADOPTION OF TENTATIVE MILLAGE RATE: There is hereby proposed to be SECTION 2. 2 levied upon all taxable real and personal property in the City of Lauderdale Lakes, except that 3 property exempted under the Constitution of the State of Florida and other laws of the State of 4 Florida, the following millage rates, on each One Thousand Dollars (\$1,000.00) of taxable value for 5 the applicable tax year for the benefit of the City of Lauderdale Lakes:

> Tentative General Millage Rate for FY 2022 8.6000 (said millage rate is 4.81%) more than the rolled back rate of 8.2050 Tentative Voted Millage Rate for FY 2022 (not included in Constitutional 10 mil cap) 1.0950
