III. Approval of Minutes from Previous Meeting:

A. Approval of December 14, 2023

Motion to approve December 14, 2023 meeting minutes was made by Board member Samuel Goodman and second by Board member Anika Omphroy.

IV. New Business

CRA Executive Director Dunmore provided an update on past and future projects managed and sponsored by the Community Redevelopment Agency (CRA). She further explained about the outreach efforts conducted by the Agency to assist property owners with the aesthetic of the buildings within the CRA district. These efforts include the creation of programs such as: Development Assistance Program, Residential Preservation and Enhancement Program and the Commercial Façade Improvement Program.

Another program sponsored by the CRA and explained by the CRA Executive Director was the Homebuyer Purchase Assistance Program. This program facilitates the purchase of few new townhouse units built by Pulte Homes in Lauderdale Lakes. It will assist qualified buyers for a limited time.

Board members shared their concerns about the aesthetic of few of the commercial plazas located within the CRA district. After an exchange of ideas, Board members agreed that it will be necessary to share with the tenants of some of these plazas, in particular nonprofit organizations, the concerns residents have about the lack of maintenance of some of the buildings.

CRA Executive Director Dunmore announced an upcoming Community Event that will be held on Friday, March 8, 2024 starting at 6:00 pm. The purpose of the event is to gather as much residents as possible to gain their ideas and thoughts about future redevelopment of Lauderdale Lakes. This information will be utilized to update the CRA Redevelopment plan.
