1. CALL TO ORDER

3. APPROVAL OF MINUTES FROM PREVIOUS MEETING

A. MAY 8, 2025 HISTORIC PRESERVATION BOARD MEETING MINUTES

Board member Warner made a motion to approve the May 8, 2025, Historic Preservation Board meeting minutes. Vice Chair Hall seconded the motion. The minutes were approved unanimously.

4. NEW BUSINESS

A. TOUR OF THE SAMUEL S. BROWN ROOM

This item was moved to the next Historic Preservation Board meeting.

Vice Chair Hall stated that Broward Commissioner Hazelle Rogers, former Vice Mayor Mark Spence and other representatives paid a visit to the Sam Brown Room at the May 6th City Commission Meeting. Suggestions were made to create some type of verbiage under each picture stating what it was. Discussion ensued amongst the Board regarding getting historical artifacts from the community to add to the room and having an avatar of a former Commissioner showcasing the room online.

B. DISCUSSION REGARDING LETTER OF NOMINATION FOR BROWARD COUNTYPIONEER

Discussion ensued amongst the Board regarding the nomination application to Vice Mayor Tycie Causwell to the Broward County Historical Preservation Board as a Broward County Pioneer. The Board will announce Vice Mayor's Causwell nomination at a future City Commission meeting.

A. DISCUSSION REGARDING RECOGNITION OF RESIDENTS 85 YEARS OLD AND OVER (ON-GOING)

B. DISCUSSION REGARDING THE PROCESS OF DIGITIZING THE CITY'S HISTORICAL ARTIFACTS FROM THE SAMUEL S. BROWN ROOM (ONGOING)

The Board discussed digitizing the items in the Sam Brown Room. the Communicantions Manager, Aubyn Lewis, stated that they can create a new facilities page and title it Sam Brown Museum or can expand the current page and add a slideshow widget to it, they can then create a slide show on the page. This would involve scanning all the documents and taking pictures of the artifacts which can be done in house and would require purchasing a light box. The other option would be an online archival service that the City would have to pay for.

Discussion ensued regarding having a YouTube page to display the artifacts and also possibly downloading pictures of the artifacts to a CD and selling it.

The Board stated that they would like to give a community member a proclamation on behalf of the Board every quarter. The proclamation should have no age limit and should focus on trailblazers. The first person suggested to receive the proclamation is Commissioner Easton Harrison to be given at a future meeting.

The Board would also like to interview and record members of the Lauderdale Lakes community to share their history of the City.

Board member Warner made a motion to cancel the July and August Board meetings. Chairperson Fyffe seconded the motion.
