Summary

This is a discussion on creating a lien processes to address further lien reduction after a settlement offer has been provided by the City upon request by the applicant.

Staff Recommendation

Background:

Resolution 06-80, Section 2a, states that a property owner who has met criteria of the Code Enforcement Lien Reduction Program for liens \$5,000.00 and above to seek review by the Special Masters. This simple means the Special Masters approve the written settlement received from the Finance Department, no further reduction is provided to the applicant.

In recent months staff has been taking request received for further reduction to the City Commission on a case by case basis. There are no administrative policies on how to address liens that cannot be enforced, liens that are old, liens that are recorded incorrectly and the list goes on. Staff is requesting a formal process be implemented to provide direction to property owners on how to resolve these type of lien request .

Currently staff has 5 application request for either a lien reduction or to settle a lien that has been foreclosed. Staff looks for direction form the City Commission. Attached is a breakdown of the different types of liens issues to be resolved.

LIEN DISCUSSION

Staff requests an administrative policy which would allow for the release of liens which are unable to be enforced against the property or property owner in exchange for an administrative fee. Examples of liens which are unable to be enforced are as follows:

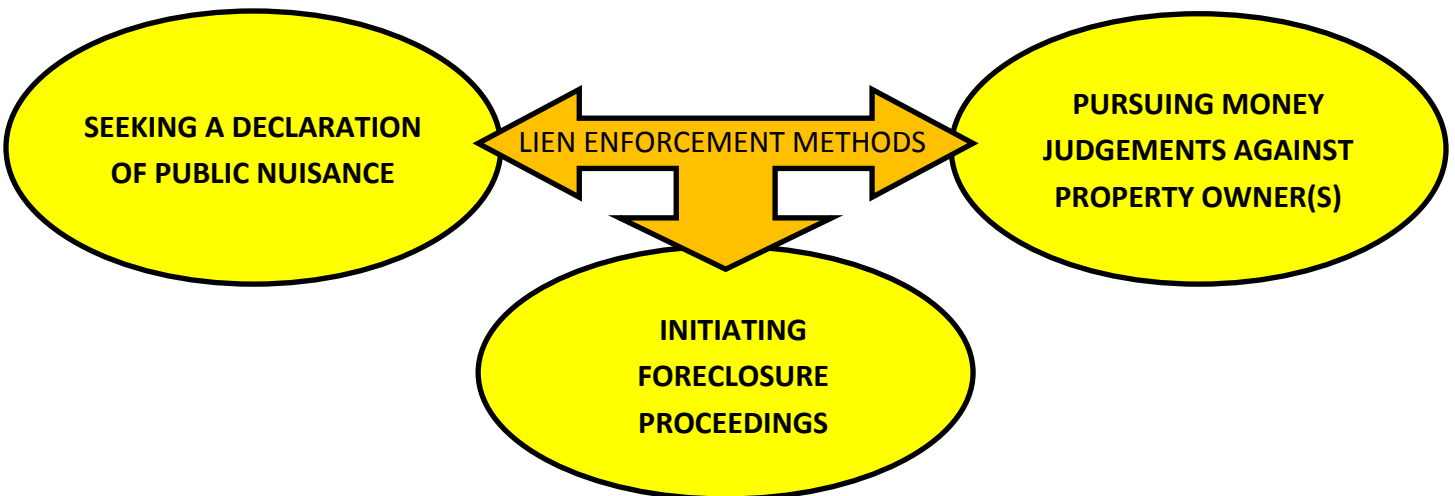
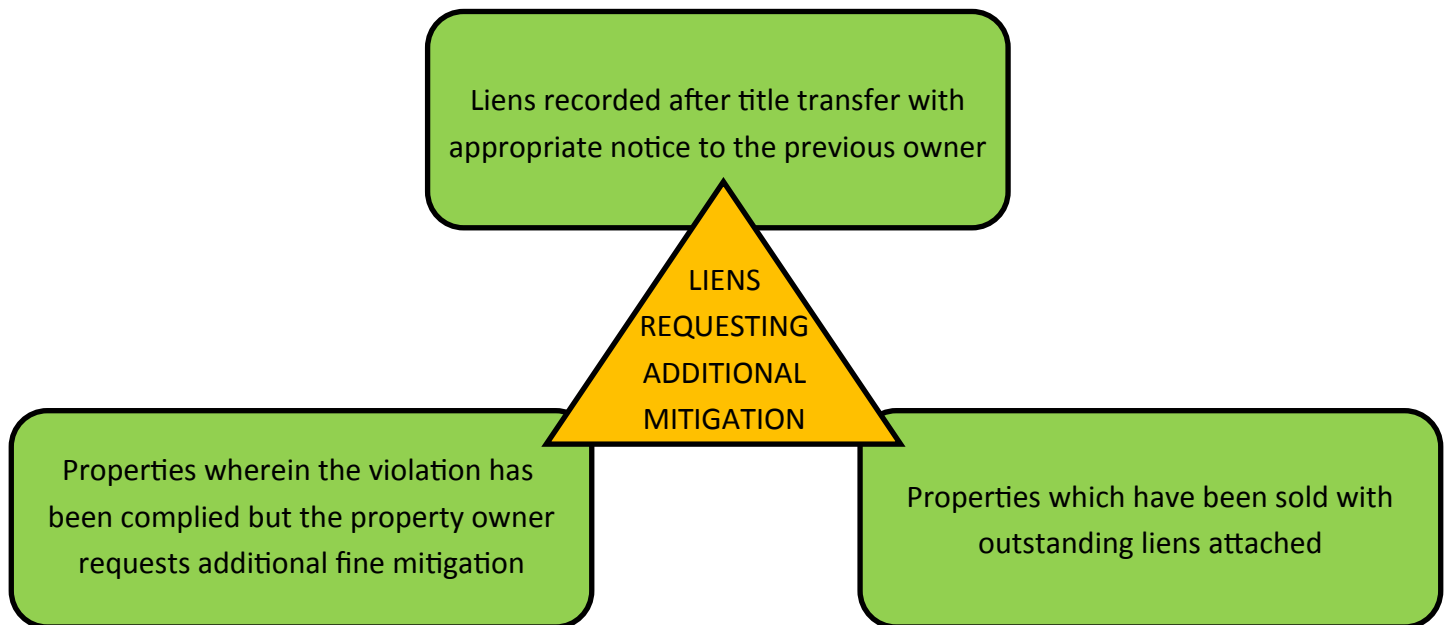
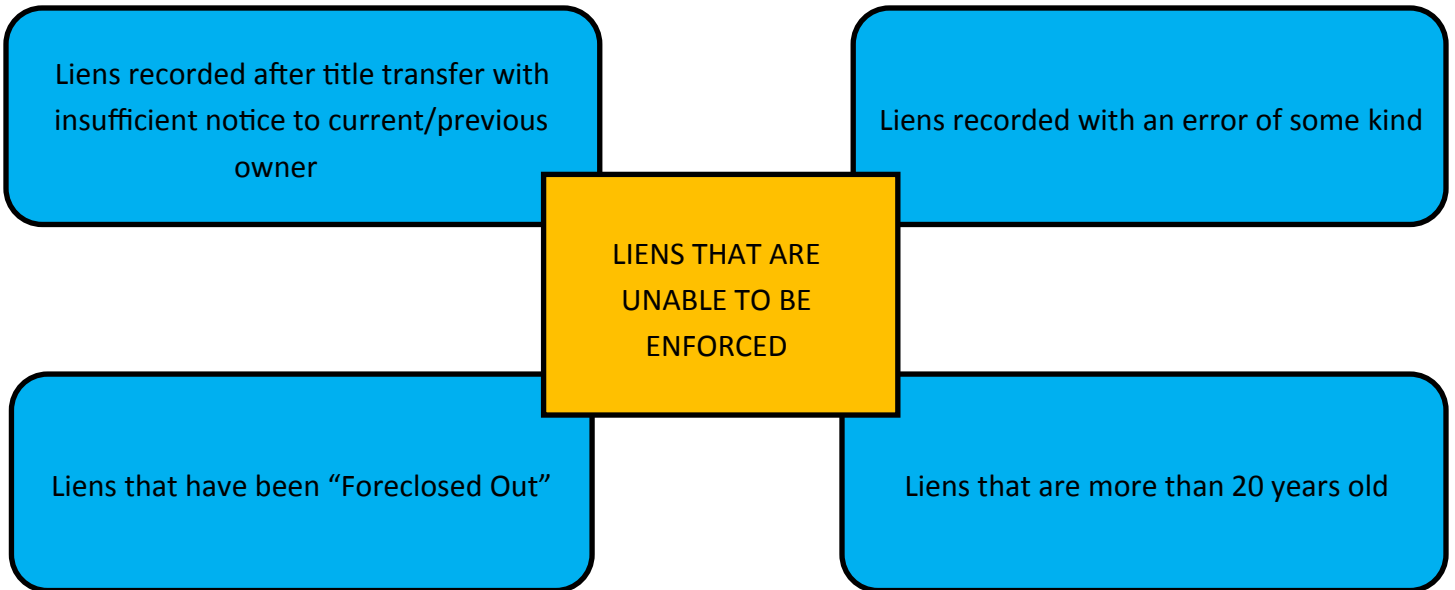
- 1. Liens recorded after title transfer with insufficient notice to current/previous owner**
- 2. Liens recorded with an error of some kind**
- 3. Liens that have been "Foreclosed Out"**
- 4. Liens that are more than 20 years old**

Additionally, staff requests that the Code Enforcement Board and/or Special Master be reinstated with the authority to reduce fines, pursuant to Florida Statute 162.09(2)(c). This would provide for a mechanism to address mitigation requests for the following scenarios:

- 1. Liens recorded after title transfer which appropriately noticed the previous owner**
- 2. Properties wherein the violation has been complied but the property owner requests additional fine mitigation**
- 3. Properties which have been sold with outstanding liens attached**

Lastly, staff and the City Attorney's Office would like clear direction on how to proceed with enforcement of outstanding liens. State statute provides for multiple courses of actions, none of which have we consistently practiced.

- 1. Initiating foreclosure proceedings**
- 2. Pursuing of money judgements**
- 3. Seeking a declaration of public nuisance**

DISCUSSION REGARDING ELECTRONIC MESSAGE BOARD SIGNS (BILLBOARDS)

Summary

This is a discussion item regarding electronic message board signs, also referred to as billboards.

Staff Recommendation

Background:

- Billboards or off-premise signs were prohibited in the City in 1978, and the existing billboards became legal nonconforming prior to the adoption of the City's Land Development Regulations (LDRs) in 2006.
- On December 14, 2010, the City Commission adopted Ordinance No. 2010-20 providing for provisions to rebuild, alter or replace nonconforming signs subject to a 50 percent or more damage and/or cost of restoration clause. However, there was no form of compatibility review.
- On March 8, 2016, the City Commission approved (3-2 vote) amendments to the LDRs - to allow existing nonconforming signs to be rebuilt, replaced or substantially altered subject to conditional use approval (compatibility review) by the City Commission. **The amendment did not allow for any relocation of billboards in the City.**

Currently, there are five (5) billboards in the City; one billboard is located on Commercial Blvd, one on State Road 7 and three on Oakland Park Blvd. There are two billboards on City-owned land (Commerce Park). The attached Exhibit shows the location of these off-premise signs.

To implement the goals, objectives and policies adopted in the City's 2010 Comprehensive Plan, staff must review billboards to ensure compliance with the requirements of the Comprehensive Plan and the Land Development Regulations for compatibility.

- Chapter 9, Sec. 914. - *Nonconforming signs*- of the LDRs indicates that conditional use review shall determine whether the proposed sign would have adverse visual impacts on the surrounding area and would be generally compatible with the Comprehensive Plan's Goals, Objectives and Policies.
- Objective 1.2, Policy 1.2.6 and Policy 1.2.7 of the City's Comprehensive Plan provides that new development and redevelopment be compatible with the surroundings and enhance the overall design and built environment consistent with the Land Development Regulations (LDRs).
- Objective 1.4, Policy 1.4.11 states "Lauderdale Lakes shall, through its continued regulation of signage in the land development regulations and establishment of design standards, balance community aesthetics, sense of place and motorist safety with way finding..."

Staff Recommendation

Based on the information presented staff finds no objection to modernizing signage need in the community when it is compatible with the vision and goals of the City. That been said, the current location of these billboards would create a visual clutter and blight, especially in the Town Center and Commerce Park.

Staff looks to the City Commission for direction as it relates to signage to ensure compliance with the City's vision for the future.

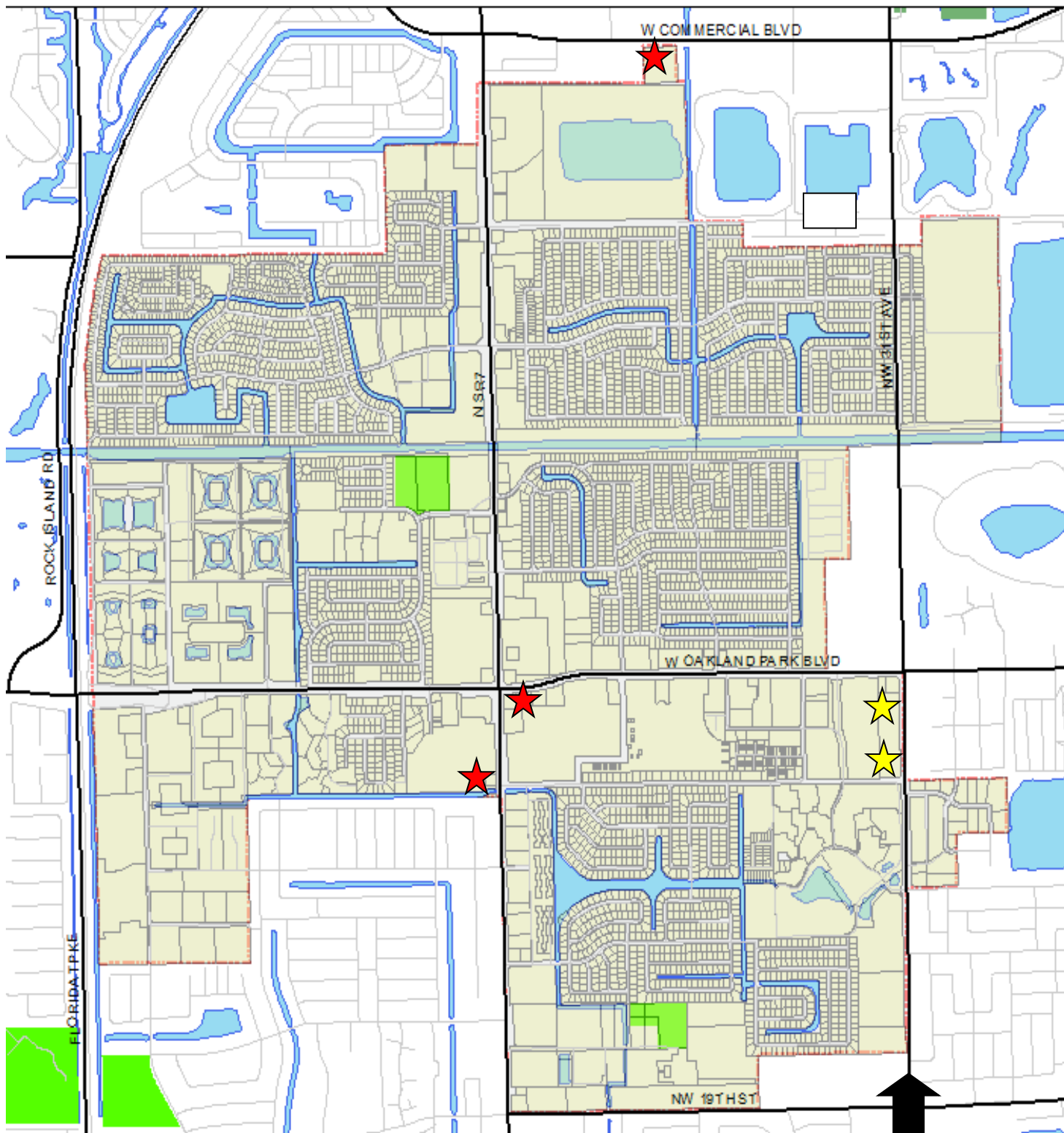
