Approved ORDINANCE 2016-29

AN ORDINANCE AMENDING SECTION 6-8(1) OF CHAPTER 6 OF THE CODE OF ORDINANCES; PROVIDING FOR THE REGULATION OF ALCOHOLIC BEVERAGE VENDING AND HOURS OF OPERATION WITHIN THE CITY; PROVIDING FOR ADOPTION OF REPRESENTATIONS; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR INCLUSION IN CODE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has consistently regulated the conduct of businesses vending alcoholic beverages with regard to hours and location of such operations, and

WHEREAS, the City Commission recognizes that it is important to strike a balance between the rights of commercial enterprises and the protections to be afforded to the residents of the City, and

WHEREAS, in the past, the City has regulated the hours of service of alcoholic beverages based, in part, on the premise that the City does not want to be a magnet to those who would come to the City, solely because of the City's extended hours of service, as compared to the more conservative hours of adjacent communities, and

WHEREAS, a segment of the commercial community has requested that the City grant a minor extension of the hours of the service of alcoholic beverages in a manner consistent with neighboring cities, and

WHEREAS, on inquiry and advice, the City Commission believes that a proper balance between the rights of the commercial enterprises and the protections of the City's residents will not be negatively impacted by a minor change in the hours during which enterprises serving alcoholic beverages may operate,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAUDERDALE LAKES as follows:

SECTION 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas Clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Ordinance.

SECTION 2. AMENDMENT: Section 6-8(1) of Chapter 6 of the Code of Ordinances is hereby amended to read as follows:

Sec. 6-8. - Additional requirements for lounges and nightclubs.

These additional requirements are intended to address and reduce the incidences of criminal activity in the city's licensed lounges and nightclubs:

(1)

Hours of operation. Lounges and nightclubs, as defined in this chapter, shall be prohibited from operating during the following hours:

Monday—Friday:	2:00 a.m. 8:00 a.m.
Saturdays:	4:00 a.m. 8:00 a.m.
Sundays:	4:00 a.m. Noon
Holidays:	4:00 a.m. 8:00 a.m.

Tuesday-Thursday:	<u>2:00 a.m.—8:00 a.m</u> .
Friday-Monday:	4:00 a.m.—8:00 a.m.
Holidays:	4:00 a.m.—Noon

SECTION 3. CONFLICT: All ordinances or Code provisions in conflict herewith are hereby repealed.

SECTION 4. SEVERABILITY: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by Page 2 of 4

any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. INCLUSION IN CODE: It is the intention of the City Commission of the City of Lauderdale Lakes that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lauderdale Lakes and that the sections of this Ordinance may be renumbered or relettered and the word "Ordinance" may be changed to "Chapter," "Section," "Article" or such other appropriate word or phrase, the use of which shall accomplish the intentions herein expressed; provided, however, that Section 1 hereof or the provisions contemplated thereby shall not be codified.

SECTION 6. EFFECTIVE DATE: This Ordinance shall become effective immediately upon its final passage.

Staff Recommendation

Background:

It is the desire of the City Commission to establish policy that facilitates transparency and accountability with respect to the use of public funds, in connection with materials, equipment, and certain professional services.

To enhance the current policies and to ensure greater transparency, City staff recommends revisions to Ordinance 2013-01, the ordinance amending the Chapter 82, Article 13, Procurement Code.

Exhibit 1

City staff recommends the following revisions to the Chapter 82, Article 13, Procurement Code:

1.Section 82-353 Definitions:

Category two means the dollar threshold, currently \$35,000.00 defined by F.S. § 287.017(43), which may be amended by the State of Florida from time to time; which shall serve as the formal solicitation threshold for purchases made on behalf of the City of Lauderdale Lakes. In the event that the State of Florida amends the category three two threshold, such change shall be reported to the city commission and the city commission shall be required to formally consent to such change prior to such new threshold becoming effective for the city.

Note the purchasing categories as defined per the F.S. § 287.017:

(1) Category One: \$20,000(2) Category Two: \$35,000(3) Category Three: \$65,000(4) Category Four: \$195,000

(5) Category Five: \$325,000

The City's purchasing thresholds per the existing ordinance:

- (1) Category One: \$2,499.99 requires one quote
- (2) Category Two: \$4,999.99 requires three quotes
- (3) Category Three: \$24,999.99 requires three quotes and agreement (in some cases)
- (4) Category Four: \$25,000 and over formal competitive process

2. Section 82-355 Responsibilities and authority:

For the purposes of transparency and accountability, City staff recommends to increase the City Manager's authority from \$25,000 to \$35,000 to approve and execute procurement-related non-capital improvement purchases.

(3) The city manager or designee shall have the authority to approve and execute all procurement-related non-capital improvement purchase orders, contracts, contract amendments and contract renewals in the amount of \$25,000.00 \$35,000, equal to or less than category two, as defined in F.S. § 287.017(2) or less.

There are no changes recommended for this procurement option.

(4) The city manager or designee shall have the authority to approve and execute all procurement-related capital improvement purchase orders, contracts, contract amendments and contract renewals up to and equal to the amount of the threshold for purchasing category two, currently \$35,000.00, as defined in F.S. § 287.017 or less; provided, however, the city commission may, at the time of the award of applicable improvement project revise such amount for such project, only. (No Changes recommended)

Staff is recommended that this section be deleted in its entirety.

- (5) The mayor shall have the authority to execute all *procurement*-related, contracts, contract amendments and contract renewals in excess of the threshold for purchasing category three, as defined in the F.S. § 287.017(3) after city commission approval. Such execution shall be attested to by the city clerk. Execution of short-term leases and other *procurement*-related purchase orders, contract amendments and contract renewals in excess of the threshold for purchasing category three shall be instruments delegated to the city manager or designee for execution.
- (6) For the purposes of ensuring the appropriate levels of authority are in place to approve and execute procurement-related contracts, amendments and renewals. This revision downgrades the level of authority from the category three to category two. The current policy does not provide any authority for items exceeding category two (items over \$35,001 to \$65,000).

3. Section 82-356 Methods of Source Selection, Local business preference:

For purposes of clarification of the existing policy, City staff recommends the following revision:

v. If a qualified local business submits a response to either an inquiry made pursuant to informal competitive conditions or a formal invitation to bid, as required in this code, and the original bid of the qualified local business is within five ten percent of the low bid, then the city shall give the qualified local business the opportunity to meet the price of the low bid. The order of preference by which the qualified local business shall be given the opportunity to match the low bid shall be from the lowest to the highest bid, as long as the initial bid was within five percent of the low bid.

I am writing in reference to the below noted code enforcement liens recorded in the public records of Broward County Florida.
