CITY COMMISSION WORKSHOP MINUTES

City Commission Chambers September 11, 2023 5:00 PM

1. CALL TO ORDER

Mayor Veronica Edwards Phillips called the September 11, 2023, City Commission Workshop to order at 5:00 p.m.

3. DISCUSSION

REVIEW OF THE SEPTEMBER 12, 2023 CITY COMMISSION MEETING AGENDA

Item 9.A. RESOLUTION 2023-107

SUPPORTING THE PROPOSED PROJECT FOR THE CONSTRUCTION OF MULTI-USE PATHS AND COMMUNITY BUS STOPS IN THE OAKLAND ESTATES LOCATED ON NW 41ST STREET TO EXTEND FROM NORTH STATE ROAD 7 TO NW 52 AVENUE WITHIN THE CITY OF LAUDERDALE LAKES

City Engineer, Maqsood Nasir, stated that the MPO's Complete Streets and other Localized Initiatives Program (CSLIP) provides funding for small local transportation projects that will improve the safety and mobility for all transportation users in Broward County. This grant program can fund projects such as complete streets projects, traffic calming and intersection improvements, ADA upgrades, mobility hubs, bus shelters, bike racks and technology advancements such as transit signal priority and traffic control devices. The application deadline is October 1st.

Item 9.B. RESOLUTION 2023-108

APPOINTING THE REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO REPRESENT THE CITY OF LAUDERDALE LAKES FOR SERVICE ON THE GOVERNING BOARD OF THE

SOLID WASTE DISPOSAL AND RECYCLABLE MATERIALS PROCESSING AUTHORITY OF BROWARD COUNTY, FLORIDA

Director of Public Works, Ron Desbrunes, spoke about the previously approved ILA with Broward County which gave birth to the Solid Waste Disposal and Recyclable Materials Processing Authority of Broward County. Each municipality needs to select a delegate and alternate delegate to govern the Authority.

APPOINTING A NEW MEMBER TO THE HISTORIC PRESERVATION BOARD

Mayor Edwards Phillips advised that Celeste Humphrey is the appointee to the Historic Presentation Board.

Item 9.D. RESOLUTION 2023-110

AUTHORIZING THE RENEWAL OF THE CITY'S GROUP INSURANCE PLANS

Director of Human Resources, D'Andrea Giddens-Jones, advised that there were no changes to the benefits providers. She announced an upcoming wellness and benefits fair.

Shaheewa Jackson spoke about the market trend increase and advised that there is no loss in plan coverage.

Item 10.A. RESOLUTION 2023-111

AMENDING THE SPECIAL EVENTS CALENDAR FOR FISCAL YEAR 2023/2024 TO INCLUDE TWO BREAST CANCER AWARENESS EVENTS

Vice Mayor Maxwell-Williams requested the addition of a health fair and dinner to be held in October in recognition of Breast Cancer Awareness Month to the special events calendar.

There was discussion regarding the cost for the dinner.

City Manager Brown Stubbs advised that the budget is \$1,000.00.

Mayor Edwards Phillips confirmed that this is a city sponsored event.

Item 10.B. RESOLUTION 2023-112

AMENDING FUNDING APPROPRIATED FOR A TEMPORARY CONTRACTUAL PUBLIC INFORMATION OFFICER POSITION AND RE-APPROPRIATE FUNDS TO THE CITY'S PROMOTIONAL VIDEO PRODUCED BY ICMA (INTERNATIONAL CITY/COUNTY MANAGER'S ASSOCIATION), IN AN AMOUNT NOT TO EXCEED \$24,300.00

Director of Financial Services, Asheley Hepburn, explained that this was originally approved under the Loss Revenue Funding and the request is to reappropriate the funds to the City's promotional video produced by ICMA.

Assistant City Manager, Peggy Castano, explained that the city was elected for film making focusing on resilience and economic growth for the city and spoke about the branding, purpose and goal.

Vice Mayor Maxwell-Williams spoke about the funds being used to assist residents.

Commissioner Causwell suggested using the funds locally.

Mr. Hepburn spoke about the funds provided for ARPA and what the loss revenue funds may be used for. He advised that the loss revenue funds can be used for any purpose.

Commissioner Spence advised that he wants to be sure that the funds are used according to what was approved by the City Commission.

There was further discussion on the use of the funds.

Commissioner Spence asked about vacant positions.

Mr. Hepburn explained that some positions are vacant and others have been filled.

Former Commissioner Beverly Williams commented as to parking issues in the City. She also commented on City buses not stopping at bus stops.
